**ORDER CONDITIONALLY APPROVING DEBTOR’S DISCLOSURE STATEMENT,

On June 4th, 2018, Atlantic Fabrication & Design LLC, debtor in the above-captioned case (“Debtor”), filed a plan and disclosure statement under Chapter 11 of the Bankruptcy Code. The Debtor is considered a small business debtor as defined in § 101(51D). Therefore, pursuant

to Fed. R. Bankr. P. 3017.1, it is so ordered and notice is hereby given that:

- A. The Disclosure Statement file by Debtor is conditionally Approved.
- B. The Plan, the Disclosure Statement, and a Ballot conforming to Official Form 314 shall be mailed to creditors, equity security holders, the United States Trustee, and all other parties of interest within seven (7) days after entry of this Order.
- C. The last day for filing written acceptances or rejections (Ballots) of the Plan is July 5, 2018.
- D. The last day for filing and serving a written objection to the Disclosure Statement and Confirmation of the Plan is July 5, 2018.
- E. A hearing on the final approval of the Disclosure Statement, if a written objection is timely filed, and for the Confirmation of the Plan, will be held on July 12, 2018, at 9:30am in the 2nd floor courtroom of the United States Bankruptcy Court for the Western District of Oklahoma, 215 Dean A. McGee Avenue, Oklahoma City, OK 73102 before the Honorable Janice D. Loyd.
